This AMENDMENT TO BYLAWS for Sans	Famille Homeowners Association,
Inc., is made as of this day of,	2013, by [at least a two thirds (2/3)
majority of the members voting at a business session	of the annual meeting by members
of the Sans Famille Homeowners Association, Inc. ("A	Association").

$\underline{W} \underline{I} \underline{T} \underline{N} \underline{E} \underline{S} \underline{S} \underline{E} \underline{T} \underline{H}$:

WHEREAS, the members of the Association desire to make certain changes in the operation and administration of the affairs of the corporation by amending the Bylaws of the Association; and

WHEREAS, Article XVI, Section 1of the Bylaws provides that changes in the Bylaws may be made by a two-thirds majority of members voting at a business session of the annual meeting of the Association or by a two-thirds majority of all votes cast in a mail ballot, provided that notice in writing of the proposed amendment shall have been sent to every member at least one month before the date of the meeting at which it is to be considered, or at least one month before the last date for the return of the ballots in the case of a mail ballot; and

WHEREAS, the members of the Association have met in a business session at an annual meeting and have approved by a two-thirds majority of members the following changes to the Bylaws in accordance with Article XVI, Section1 of the Bylaws; and

WHEREAS, all Board-developed amendments are required to be approved before submission to the membership at a meeting of the Board at which two-thirds of its members are present and voting in favor of such amendment, and the following amendments were so approved prior to submission to the membership;

NOW THEREFORE, the Bylaws of the Association shall be amended as follows:

1. Article IX, Section 1, Subsection 2 is amended by adding the following underlined language and deleting the language that appears struck through:

An <u>independent</u> Audit Committee, <u>which shall consist of the Treasurer, no other Board Members</u>, and at least two Owners nominated and elected at <u>the annual meeting</u> which shall conduct or supervise the annual audit <u>or review</u> of the Association's books and approve the annual budget and statement of income and expenditures to be presented to the membership

at its regular annual meeting as provided in Article XI, Section 8(d). The Treasurer shall be an ex-officio member of the Committee.

2. Article XI, Section 8(d) is amended by striking the reference to "check" and adding the following underlined language:

Treasurer. The Treasurer shall receive and deposit in appropriate bank accounts all monies of the Association and shall disburse such funds as directed by resolution of the Board of Directors; shall co-sign all ehecks and promissory notes of the Association; keep proper books of account; cause an annual audit or review of the Association books to be made by a certified public accountant or by an independent Audit Committee as described in Article IX, Section 1, above, consisting of at least 3 people appointed by the Board, which appointees may consist of members or nonmembers of the Association, at the completion of each fiscal year; and shall prepare an annual budget and a statement of income and expenditures to be presented to the membership at its regular annual meeting, and deliver a copy of each to the members.

3. All remaining provisions of the Bylaws remain unchanged and in full force and effect.
